Ch. Kuznik gave an overview of how the apparatus replacement plan works. In the original agreement, specific rolling stock units were designated as Western Hills property. Those units have aged out of service. (20-year service life) 12 years of front-line operation and 8 years of reserve operation until the unit is replaced. The proceeds of those sales were received by the district.

The current service agreement annual cost funds apparatus replacement. The Current design/build process for a fire engine is a two- to three-year process. A new

engine is approximately \$1,000,000 and the equipment adds another \$200,000 to the cost. The service level provided by Greeley Fire to the District exceeds the response level of other surrounding departments. The funding formula needs to be reviewed for appropriate levels of funding.
