COVID Information – The City of Greeley is operating under level Red guidelines.
Offices are closed to the public and many employees continue to work from home.
The State of Colorado may change levels at the end of the month.
CDC has stated that individuals that are fully vaccinated do not need to isolate in case of an exposure unless they exhibit symptoms.
There are testing dates and vaccinations available during March.

Calls down approximate 7%. This may be due in part to COVID calls.

Greeley Fire is responding to 1 or 2 COVID calls per day.

Retirement of Chief Lyman, and two push in ceremonies took place for new Engine 6 and new Ladder 5.

The fire on Balsam Avenue was not within the Western Hills District.

Three main priorities of GFD

EMS Transport model – contract with Banner expires in November of 2021. Meeting with officials to determine extension or request for proposals

Policy Updates - working with Lexipol to review/revise all policies for Fire Department.

Parking Lot – The City understands that they are responsible for repairs and it was not currently in the budget. However, the City found funds to complete the process maybe in March.

Dictoguard is ordering the hardware for the building access upgrades.

Time line for Chief search -39 applicants; approximately  $\frac{1}{2}$  were declined for lack of qualifications. 15-20 applicants received phone interviews and 10-12 were given a writing assignment. Anticipate an announcement in May.
